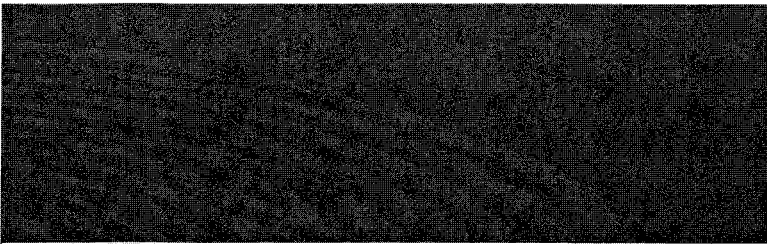

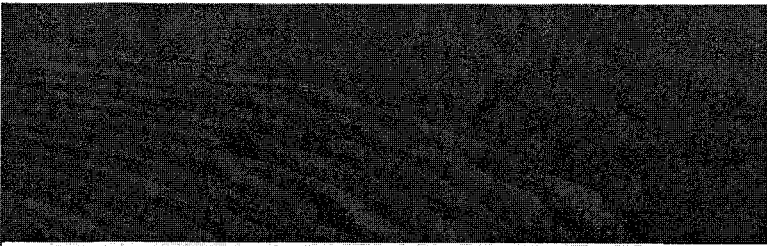
### Statement on Disclosure of Visa Records
