- 1. (U) SUMMARY. As of August 1, 2004, Coalition Forces exercised some degree of security control over 9,374 individuals inside Iraq. The detainee population on August 1 consisted of (A) 12 High-Value Criminals (HVCs) housed in Coalition facilities under Iraqi legal custody, (B) 84 High-Value Detainees (HVDs) in Coalition custody, (C) 5,439 security internees in Coalition custody, and (D) 3,839 protected persons under Coalition security control
- 2. (C) The possible dispositions for these various groups are: (A) HVCs conviction or acquittal by the Iraqi Special Tribunal (IST); (B) and (C) release, supervised release, continued detention, or referral for prosecution to the IST or the Central Criminal Court of Iraq (CCCI); (D) repatriation, resettlement, and/or determination of refugee status. END SUMMARY.

(A) HIGH-VALUE CRIMINALS: "THE TWELVE"

- 3. (S) Former Iraqi President Saddam Hussein and eleven other High-Value Criminals (HVC), often collectively termed "the twelve," are currently housed on the grounds of Baghdad International Airport (BIAP) at Camp Cropper.
- 4. (U) Legal custody of all twelve HVCs passed to the Iraqi Interim Government (IIG) on June 30, 2004, with their referral for prosecution to the Iraqi Special Tribunal (IST). Physical custody has been retained by Multi-National Force-Iraq (MNF-I) at the request of the IIG.
- 5. (U) The IST is preparing charges against the twelve with the assistance of the Embassy-based (and Department of Justice-affiliated) Regime Crimes Liaison Office (RCLO). Charges are not expected to be finalized for six months or more. All HVCs will have access to legal counsel.
- 6. (U) As the twelve HVCs are in (Iraqi) criminal custody, they are no longer considered Enemy Prisoners of War (EPWs), and are no longer covered by the protections of the Geneva Conventions. However, MNF-I ensures that all twelve are treated in a manner consistent with the rights and protections afforded under Geneva Conventions III or IV.

(B) SECURITY DETAINEES: HIGH-VALUE DETAINEES

- 7. (S) 84 additional High-Value Detainees (HVD) are currently housed in MNF-I custody at Camp Cropper. Primary authority for all HVDs is retained by MNF-I.
- 8. (C) MNF-I bases its legal ability to retain custody of all 84 HVDs on (a) the provisions of UN SCR 1546, which states that "the multinational force shall have the authority to take all necessary measures to contribute to the maintenance of security and stability in Iraq;" and (b) international law pertaining to the conduct of international war.
- 9. (C) In addition, a number of the HVDs are EPWs and continue to be held pursuant to Geneva Convention III.
- 10. (S) All HVDs have been designated by MNF-I as being of special intelligence interest on the basis of their involvement in or knowledge of illegal weapons programs and/or terrorism, war crimes, and/or POW/MIA issues.

11. (S) MNF-I has completed security assessments of all 84 HVDs. As appropriate, the HVDs continue to be

- 19. (U) The Combined Review and Appeal Board, which is expected to stand up by the middle of August, will be made up of six Iraqi Interim Government (IIG) representatives (two each and an alternate from the Ministries of Justice, Human Rights, and Interior) and three MNF-I representatives (MP, MI, and JAG).
- 20. (U) The Combined Review and Appeal Board will report its recommendations of release, conditional release, or continued detention, to the Deputy Commanding General Detainee Operations (DCG-D). In cases in which there is no Board consensus, the DCG-D will consult with the Iraqi Ministry of Justice before making a final determination.

(C) SECURITY INTERNEES: GENERAL POPULATION

- 22. (U) The majority of the 5,439 security internees in the general population are housed either at the Baghdad Central Correctional Facility at Abu Graib (population 2,413) or Camp Bucca, near Umm Qasr (population 2,601). An additional twelve detainees are currently held in MNF-I medical facilities for treatment. (Population numbers are for August 1, 2004.)
- 23. (C) Security internees in custody prior to June 28, 2004 who remain in custody, do so on the same legal understanding described in paragraph (8). All new detainees introduced into MNF-I custody are introduced on the same legal basis.

- 29. (U) With the inception of the Combined Review and Release Board discussed in paragraphs (17) and (18), all internee files will be discussed at the Combined Review and Appeal Board for the Board's recommendation as to release (including referral to the CCCI), conditional release, or continued internment on security grounds.
- 30. (U) Of the 84 HVDs and 5,439 security internees whose cases will be considered by the Combined Review and Appeal Board, 1,489 (43 percent) have been judged by MNF-I to pose an extreme threat upon release, 772 (22 percent) a high threat, 1,180 (33 percent) a medium threat, and 85 (2 percent) a low threat.
- 31. (U) The Combined Review and Appeal board is expected to complete a review of all internees by November 1, 2004. The cases of those internees recommended for further detention will be reviewed every 60 days thereafter (this review is required only every six months).

- (D) PROTECTED PERSONS: THE MUJAHIDEEN-E-KHALQ
- 32. (U) 3,839 members and former members of the USG-designated foreign terrorist organization Mujahideen-e-Khalq (MEK) are currently resident at Camp Ashraf in Diyala Province under Coalition guard and protection.
- 33. (U) MNF-I has designated these 3,839 individuals as protected persons under the Fourth Geneva Convention and considers the restrictions placed on MEK travel outside the compound and on visitor entry as "measures of control and security" permitted under Article 27 of IVGC.
- 34. (U) Those 74 residents of Camp Ashraf who are citizens or legal residents of third countries are permitted to repatriate with the approval of their respective governments. MNF-I and Post are currently facilitating a number of possible repatriations.
- 35. (U) ICRC has been invited to visit Camp Ashraf to conduct individual interviews with the residents of the Camp. It is expected that these interviews may result in ICRC's recommendation that UNHCR make a determination of refugee status in many cases.

SUBJECT: 764 MNF-I DETAINEES APPROVED FOR RELEASE BY CRRB

1. (C) Summary. The joint Iraqi/MNF-I Combined Review and Release Board has reviewed 1,056 files since August 21, 2004, and has recommended a total of 764 (64%) MNF-I

security internees for release.

End summary.

2. (C) Between August 21 and September 14, 2004, the Combined Review and Release Board (CRRB) reviewed the files of 1,056 security detainees in MNF-I custody at thrice-weekly meetings held in central Baghdad. At the current rate, the six Iraqi and three Coalition voting members of

the CRRB will have reviewed the remaining security internees available for review by the end of October.

3. (C) Of the 1,056 security detainees whose cases have been reviewed by the CRRB, 292 (27%) have been recommended for continued internment, 389 (37%) for unconditional release, and 375 (36%) for release with a guarantor. In the cases of the last, MNF-I originally envisioned the Iraqi Ministry of Justice identifying and signing up appropriate community or religious figures, prominent family members, or local government employees, to sign and vouch for the future good conduct of those released.

7. (C) Detainees approved for unconditional release and those with approved guarantors will be released roughly once per week, in large regular tranches, and transported by bus to local police stations in the towns and cities of

their residence or initial arrest. Detainees recommended for continued internment on the grounds that they continue to pose an imperative threat to security (as were 292 of the first 1056 considered by the CRRB) will have their cases reviewed again with an eye to collecting sufficient evidence to refer these cases for criminal prosecution in the Central Criminal Court of Iraq (CCCI).

8. (C) In addition, MNF-I may employ a team of three attorneys, nominated by the Ministries of Justice, Interior, and Human Rights, to examine Iraqi records for outstanding charges or pertinent information regarding detainees recommended for continued internment. While the poor quality of Iraqi record-keeping may complicate such

investigations, MNF-I may be able to assist the IIG in linking and improving the quality of records databases to this end.

- 1. (C) Summary: Seventy-one detainees confirmed as being under the age of eighteen were held in MNF-I custody as of September 17, 2004 for imperative reasons of security as authorized by UNSCR 1546. Post provides the following information in response to recent media coverage of the situation of juvenile detainees in MNF-I custody and as background for Department responses to inquiries about this coverage. End summary.
- 2. (C) Juvenile security detainees are generally kept segregated at MNF-I detention facilities at the Baghdad Central Correction Facility at Abu Ghraib and at Camp Bucca, near Umm Qasr, awaiting review, release, or transfer to the Iraqi justice system. Advanced hospital facilities and psychological and psychiatric care are available, as are educational and family visitation programs. ICRC makes regular inspection visits to all MNF-I detention

facilities, including Abu Ghraib and Camp Bucca.

- 3. (C) Dates of initial detention can be broken down as follows: approximately 1% of juvenile security internees were first detained in the period May-July 2003; approximately 7% were first detained in August-October 2003; approximately 16% were first detained in November 2003-January 2004; approximately 29% were first detained in February-April 2004; approximately 32% were first detained in May-June 2004; and approximately 15% were first detained in or since August 2004.
- 4. (C) Common causes for internment are positive explosives test results, placement of Improvised Explosive Devices (IEDs), arson, possession of IED components, sniper rifles, or other illegal weaponry, and involvement in mortar or other violent attacks on Coalition Forces. All juvenile detainees currently held in MNF-I custody are male.
- 5. (C) All juvenile detainees have been expedited for review by the joint IIG/MNF-I Combined Review and Release Board (CRRB), which commenced in August 2004, and whose recommendations are forwarded to the Deputy Commanding General for Detainee Operations for his final decision in consultation with the Iraqi Ministry of Justice. The CRRE has reviewed the files of and made recommendations on sixty-two of the seventy-one detainees. Seven remaining have been placed temporarily on hold by Military Intelligence; an additional two will see the board soon.
- 6. (C) Of the sixty-two juvenile detainees reviewed by the CRRB, twenty-eight have been recommended for unconditional release and sixteen have been recommended for release with a guarantor. In the latter cases, the Iraqi Ministries of Justice and Human Rights have been asked to identify appropriate guarantors, such as family members, community or religious leaders, or local government employees, to sign for the behavior of individual juveniles. Detainees recommended for unconditional release are departing MNF-I custody rapidly in a series of large-scale releases starting September 15, 2004; detainees recommended for release with a guarantor will depart as soon as suitable guarantors are identified by the IIG.

1. (C) SUMMARY: S/WCI Ambassador Pierre Prosper met September 6 with MFA, family-members of Kuwaiti detainees at Guantanamo, National Committee for Missing and POW Affairs (NCMPA), and Task Force Hope (TFH, the Kuwaiti interagency team searching for missing persons in Iraq). Local media reported on the visit. On Iraq, Amb. Prosper stressed the USG's commitment to bringing Iraqi war criminals to justice, with Iraqis taking the lead in prosecuting them.

TFH and NCMPA both praised Coalition support for their work and sought help in resolving specific issues (detailed below) including access to information from former Iraqi officials

decision-process for each detainee, and said he was pushing the system to focus on the Kuwaitis, among others. He explained that there are over 650 individuals detained at Guantanamo from some 44 countries. In many cases, they have claimed to be innocent, but evidence has emerged indicating that they are members of Al-Qaeda. Some openly say they will commit terrorist acts if released. The investigative process is long, because the detainees' statements have to be checked out, often in several countries. Six detainees have been selected for prosecution at Guantanamo, some have been turned over to their home countries, and over 60 have been released, mostly Afghans and Pakistanis. This is no surprise: someone who really was just a cook or a driver, rather than a member of Al-Qaeda or the Taliban, would most likely be from the local community.

11. (C) Amb. Prosper said he had visited Guantanamo twice, most recently about six weeks earlier. Nobody is being tortured or abused; all detainees are receiving good, humane treatment. Some live in groups and play sports, all receive full medical care "from eyeglasses to reconstructive surgery" and three culturally-appropriate meals per day. The average weight gain is 13 pounds. They have the Quran and can worship. "Their biggest problem is that they are not free to leave." Two of the three juveniles could be released as soon as suitable shelter is found for them so that they do not become fighters again, but the psychologists say their

departure would be devastating for the third, who is not ready for release (all three live together; formerly illiterate, they now have a teacher). The USG has a weekly interagency meeting on this issue, involving the White House and the State, Defense, and Justice Departments. The construction of new facilities does not imply that we wish to keep all current inmates indefinitely: the Global War On Terrorism is continuing, so we may need to bring more people to Guantanamo, even if we release many who are there now.

12. (C) COMMENT: Amb. Prosper's visit was well received by the GOK, and we are certain that the families of the Guantanamo detainees genuinely appreciated his taking the time to meet and listen to them.



- 1. (C) AMBASSADOR: OUR AFRICA WATCHERS IN LONDON THOUGHT YOU WOULD BE INTERESTED IN THE BELOW ITEMS. NO ACTION REQUIRED.
- (U) GUANTANAMO DETAINEES STORM INTENSIFIES; PM WRITES THE SECRETARY; ALLEGATIONS OF TORTURE IN BAGRAM
- (U) NEARLY-ALL UK MEDIA HIGHLIGHTED THE UK DETAINEE STORY, DESCRYING U.S. BEHAVIOR. THE "ECONOMIST" WEEKLY, USUALLY SYMPATHETIC TO THE USG, RAN ON ITS COVER, "UNJUST, UNWISE, UNAMERICAN: WHY TERRORIST TRIBUNALS ARE WRONG." THE DAILY PAPERS ALL TRUMPETING WHAT WAS PERCEIVED AS A U-TURN BY PM BLAIR IN CALLING FOR THE BRITISH SUSPECTS TO BE TRIED IN THE UK. THE STORIES KEYED-OFF A STATEMENT FROM THE PM'S OFFICE, RELEASED LATE ON JULY 10, THAT SAID:
- "...WE HAD BEEN IN REGULAR DISCUSSIONS WITH THE U.S. ABOUT THE DETAINEES FROM THE TIME THE FIRST UK NATIONALS HAD ARRIVED THERE IN JANUARY 2002.
