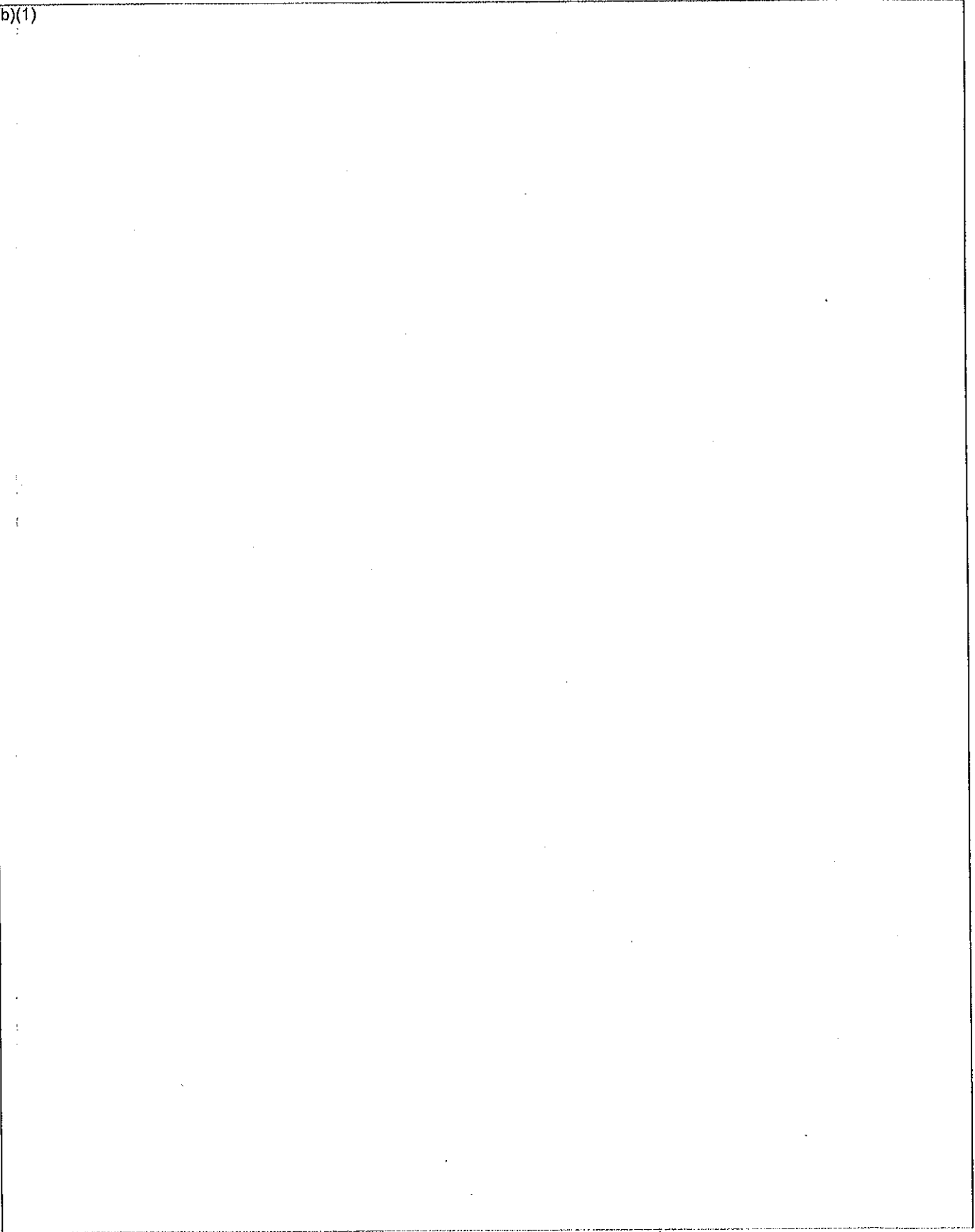

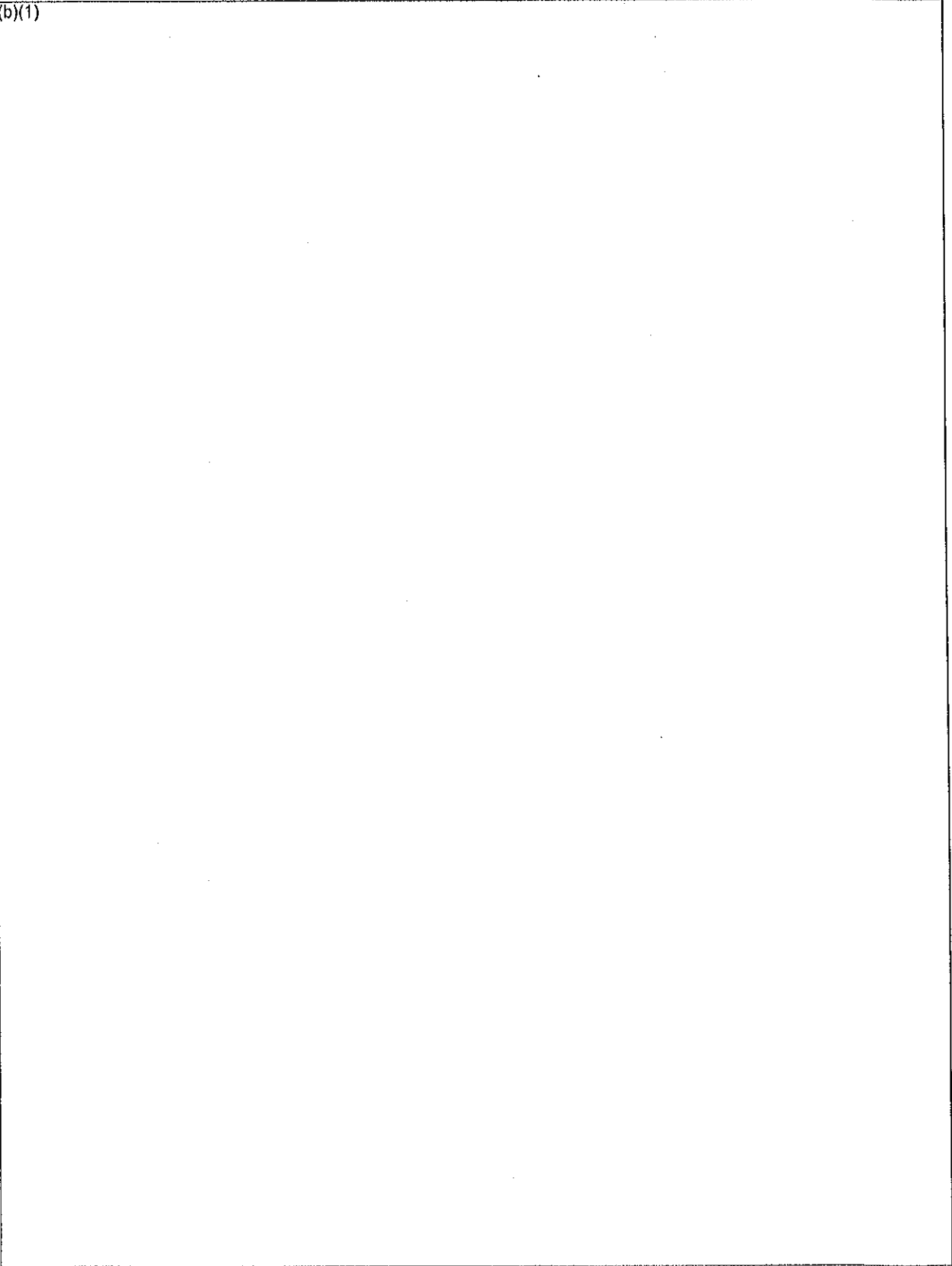

General Guidelines:

Recommend a consistent, process oriented, approach when dealing with dignitaries.

Not all visits require the same "standardized" approach. The following template may alleviate confusion and awkward situations:

- Arrival: Greet at the River Entrance
- Photo-op: Location TBD
- Gift exchange: (if initiated by visiting dignitary)
- Private Office Call:
 - A courtesy *if* time permits – should not be assumed for all visits – may be employed to enhance relations.
- Allows the delegation and OSD staff, to get situated for the meeting
- Meeting/Plenary: Conference room (b)(6)
- Lunch: (recommended if appropriate – generally only for the first official visit)
- Farewell: The Secretary or Deputy Secretary will normally escort the visitor to the River Entrance
- Dinner: (recommended if appropriate – generally only for the first official visit)

While all visits are unique, the attached checklist will be beneficial in the planning and preparing schedule proposals.

Once an official visit is scheduled, OSD protocol will coordinate a meeting between the desk officer, executive agent (if assigned) security and protocol. During the meeting the following will be addressed:

- Requirement for Letter of Welcome (official visit only)
- Translation/interpretation requirements
- Dietary considerations
- Complete itinerary (Non-DoD meetings – White House, State Department, NSC...)
- Names and phonetic spelling of the delegation

Note 1: Honors:

- The status of the visit (official or unofficial) and the position of the visiting foreign dignitary determine honors rendered.
- A visit is determined to be "official" when the President, Secretary of State, Secretary or Deputy Secretary of Defense have extended an invitation.
- A visit is considered "unofficial" if no formal invitation has been extended.
- In general honors rendered to foreign dignitaries are either a Full Honors Arrival Parade or an Honor Cordon.
- Full Honors Arrival Parade is rendered for Chiefs of State, Heads of Government and Ministers, and Deputy Ministers, of Defense (MOD) on their first "official" visit.
- The Full Honor Arrival Parade, on the Upper River Parade Field, consists of all or part of the following (Chiefs of State and Heads of Government differ slightly from Ministers):
 - Ruffles and flourishes and a gun salute
 - Inspection of troops
 - National Anthems (visiting country followed by the U. S. National Anthem)
 - Fife and Drum troop and review (Chief of State and Heads of Government)
- An Honor Cordon is rendered for "unofficial" visits *or* if the visitor has previously visited the current administration.
- Ministers of Foreign Affairs warrant an Honor Cordon.
- Unless specifically *not* recommended, Honors should be rendered.

Note: Exceptions are made to the type of honors rendered for Chiefs of State and Heads of Government at the requests of the President.

Note 2: The tables in the Secretary and Deputy Secretary's office can comfortably sit six - eight if necessary. Attendees generally include three to four from OSD (SecDef, Senior Policy rep plus CJCS, DepSec and/or the Ambassador as appropriate) and three to four from the visiting delegation.

- For office calls and private meetings fewer attendees are better.
- If necessary, interpreters may be seated behind the principals.

Meetings/Plenaries may be conducted in (b)(6) (SecDef dining room), (b)(6) (SecDef conference room) or (b)(6) (DepSecDef conference room).

- The SecDef conference room is equipped for simultaneous interpretation.
- When translation is required, a qualified State Department interpreter will be present to translate for the Secretary and U.S. delegation.

Note 3: Participation should be limited to those persons required to accomplish the meeting agenda/objective -- including a note taker.

- Policy will recommend, based upon the agenda, attendance by the Deputy Secretary and/or the Chairman/Vice Chairman of the Joint Chiefs of Staff the Deputy Secretary.

Note 4: Gift exchanges are traditionally initiated by the Visiting Dignitary - protocol does not encourage or solicit gift exchanges but it is important to know if a visitor is presenting a gift so the Secretary is prepared to reciprocate.

- Gifts can be exchanged in several different ways, two common methods are presentation style (principal to principal) or behind the scenes (protocol to protocol).

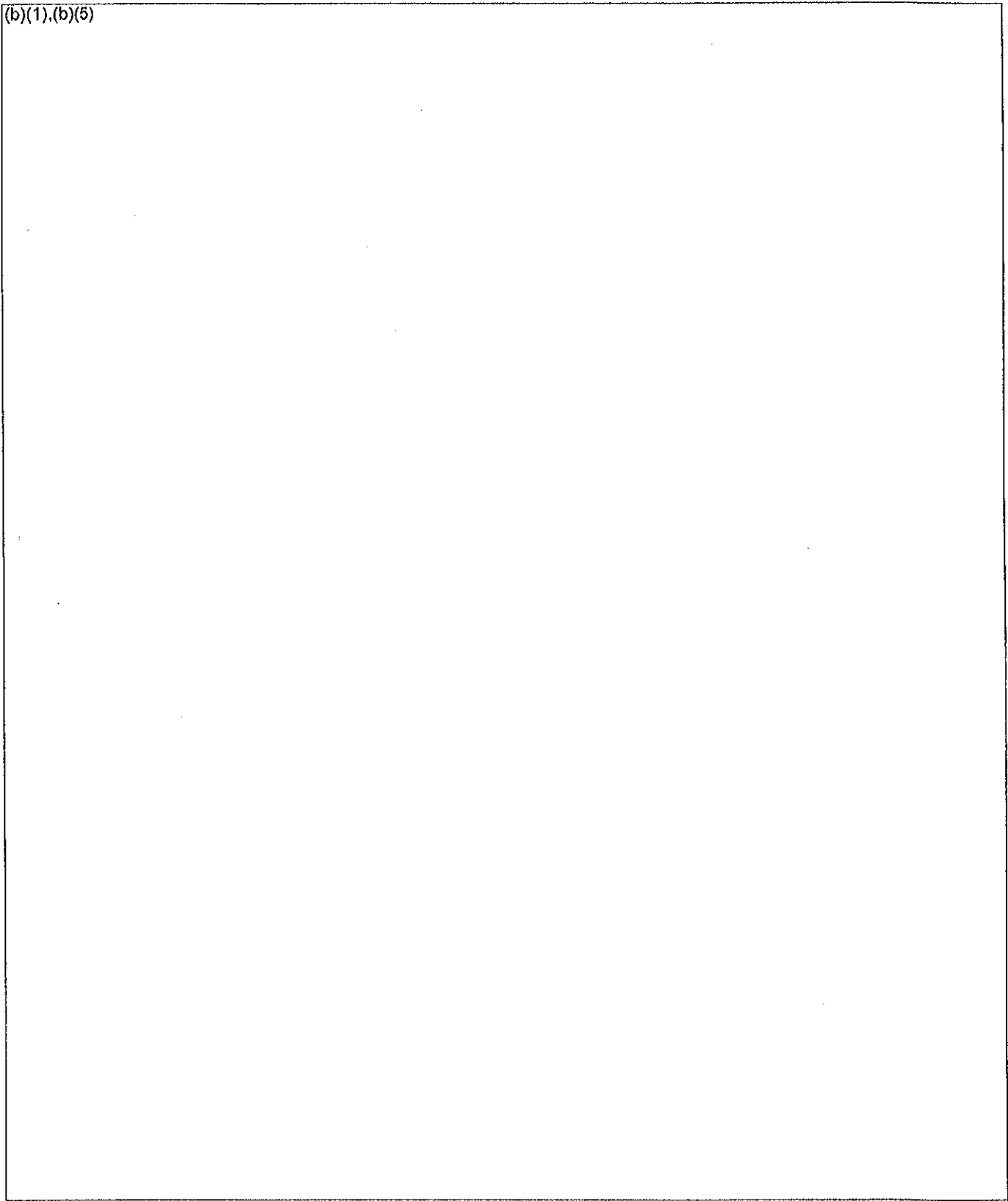



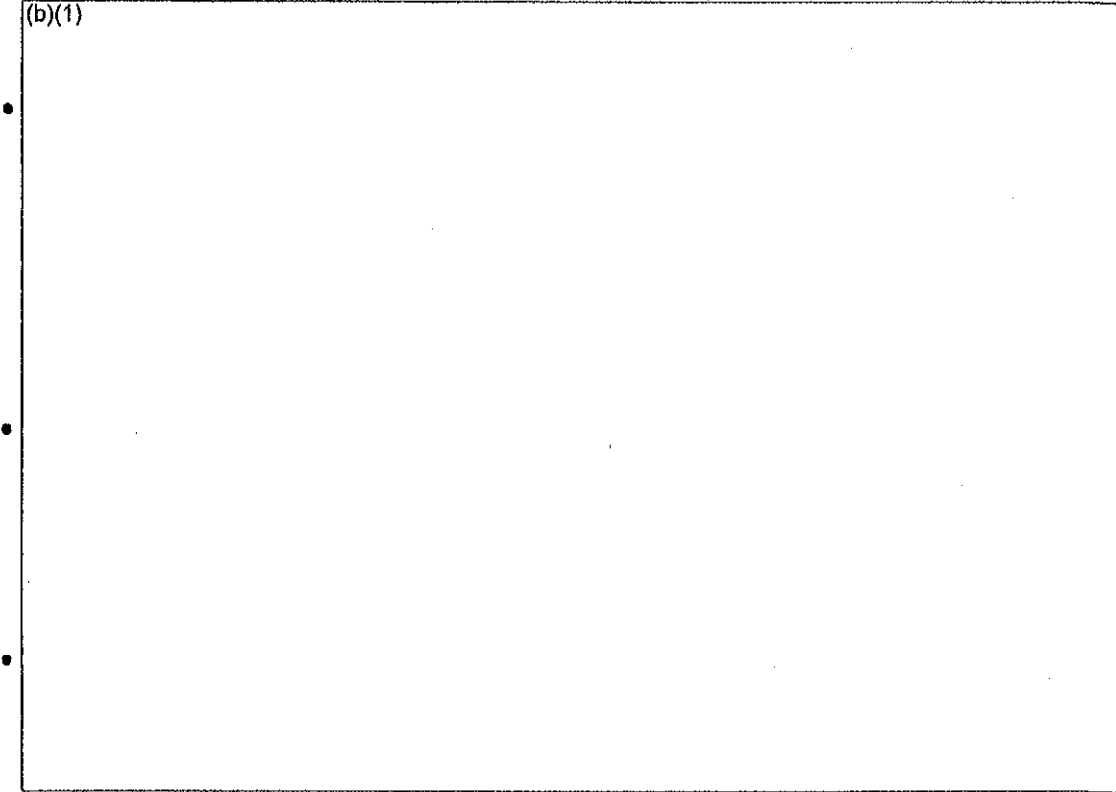
