We also had a meeting with the Boston Police Department and local ACLU, MIRA, AILA, Catholic Charities, Progressive Latino and other group representing alien interests. This meeting was given the go ahead by SC at the HQ level. The subjects covered were the number of aliens encountered by SC and the level I, II, III. The outcome was we will continue to operate and we will continue with the screening of foreign nationals who are arrested and fingerprinted. The major concern was/is ICE taking every alien the police encounter into custody, and what the difference is between levels I, II III. The results of the meeting were as expected, we agree to disagree. We did go over the statistics and the problem of at the time of arrest an alien is considered a "criminal", but that when it is

time for removal they are not a criminal unless they have been convicted. The local ACLU had issue because the ICE FOIA charts reflect that more "non-criminals" than criminals are being removed by ICE as a result of SC. We explained that ICE uses two different uses of the word "criminal" on the chart; one for arrest and one for removal purposes. Level is defined by arrest or most egregious conviction at time of arrest, but when it comes to removal data the Level is classified by convictions not arrests. The indication that non-criminals are being removed was their concern. WE explained that regardless of the term being used by ICE for removals, all of the aliens had been arrested for either Level 1, 2, or 3 offenses.

There was a similar outreach held in Boston on January 20, 2011, hosted by (b)(6) (b)(7)(c), Senior Public Engagement Officer, OSLTC. The roundtable was set up and headed by OSLTC and the discussion involved much of the same participants mentioned above, to also include (b)(6) (b)(7)(c) (OCC Boston), (b)(6) (b)(7)(c) (HQ), HSI SAC Foucart, and representing ERO was AFOD (b)(6) (b)(7)(c), AFOD (b)(6) (b)(7)(c), and AFOD (b)(6) (b)(7)(c). The roundtable discussion went much the same as above - mainly an education of SC.

FOD Chadbourne, DFOD (b)(6) (b)... and AFOD (b)(... met with MA Executive Office of Public Safety Undersecretary (b)(6) (b)(7)(6) today, January 26, 2001, in Boston. The same topics as above were discussed. EOPSS is concerned about the advocacy groups and immigrant/alien communities view on SC. They informed the FOD that the Governor's Office had erroneously indicated in December that MA was going to sign the SC MOA, when in fact they are still discussing the issue both internally and externally. EOPSS' concerns echoed those of the advocacy groups, with their primary worry being what "political" backlash may come from signing off on SC. There was no decision made today that MA would sign off on SC.
