WHEREAS defendant United States Immigration and Customs Enforcement ("ICE") and plaintiffs the National Day Laborer Organizing Network, Center for Constitutional Rights, and Immigration Justice Clinic of the Benjamin N. Cardozo School of Law (collectively "Plaintiffs") entered into an agreed upon Final Production List Stipulation ("FPL Stipulation") on July 12, 2011;

IT IS HEREBY STIPULATED AND AGREED, by and between Defendant ICE and Plaintiffs, as follows:

1. ICE will apply search terms provided by Plaintiffs (as defined below and listed on Exhibit A) against the records ICE collected in response to the FPL Stipulation to further cull the records to be reviewed and processed. Plaintiffs agree that, pursuant to paragraph 11 of the FPL Stipulation, ICE is not obligated, in connection with this litigation, to review, process, or

produce to Plaintiffs any records collected by ICE in response to the FPL that are not identified by Plaintiffs' search terms.

- 2. ICE will prioritize the review and processing of records responsive to such search terms in accordance with the priority list provided by Plaintiffs ("FPL Search Groups"), attached as Exhibit A.
- 3. ICE will review, at a minimum, an average of 1,500 "Reviewable Items" (as that term is used in reports produced by the review platform Clearwell) every three weeks, and ICE will process and produce any responsive records reviewed during that three week period on the following production dates:
 - a. November 15, 2011
 - b. December 6, 2011
 - c. December 27, 2011
 - d. January 17, 2012
 - e. February 7, 2012
 - f. February 28, 2012
 - g. March 20, 2012
 - h. April 10, 2012
 - i. April 17, 2012
- 4. ICE will provide to Plaintiffs on each production date a brief summary of the number of Reviewable Items reviewed and processed from each Search Group related to the production on that date.

- 5. ICE will provide to Plaintiffs within 5 days of a production date an estimate of the number of Reviewable Items that will be reviewed, processed and/or released for the upcoming production.
- 6. The parties will comply with this stipulation in good faith..
- 7. ICE will notify Plaintiffs of any additional FPL Reviewable Items identified after the signing of this stipulation.
- 8. The parties agree that the United States District Court for the Southern District of New York shall retain jurisdiction over any controversy or claim arising out of or relating to this Stipulation and Order.
