Kevin Ovenden, secretary-general of the British Viva Palestine organization and aide to British MP George Galloway, has said that in another two months several aid ships will set out from Cyprus to Gaza.

Ovenden added that after Britain's parliamentary elections in May 2010 the Artery of Life 4 convoy will set out for Gaza, with the participation of Venezuelan President Hugo Chavez and renowned activists who opposed South Africa's apartheid regime.

Last month, Galloway brought the Artery of Life 3 convoy to Gaza.
