This is in response to your Central Office Administrative Remedy in which you appeal your continued placement in the Communication Management Unit (CMU) at USP Marion. You believe you are entitled to due process or a hearing. You request to be transferred out of the CMU.

The Bureau of Prisons has the authority to make housing unit and institution assignments that support the security and orderly operation of its institutions. The CMU was established to house inmates that due to their current offense, offense conduct, or other information, required increased monitoring of communication between inmates and persons in the community in order to protect the safety, security, and orderly running of the institution and the public. The CMU is a self-contained general population housing unit that can house all security levels and provides for greater management of an inmate's communication. 

The Bureau of Prisons has the authority to make housing unit and institution assignments that support the security and orderly operation of its institutions. The CMU was established to house inmates that due to their current offense, offense conduct, or other information, required increased monitoring of communication between inmates and persons in the community in order to protect the safety, security, and orderly running of the institution and the public. The CMU is a self-contained general population housing unit that can house all security levels and provides for greater management of an inmate's communication. Designation to the CMU is not punitive.

Our review finds you have been appropriately designated to the CMU. As you so indicate in your appeal, your designation to the CMU was not a disciplinary sanction, therefore, there are no due process rights or right to a hearing attached to this administrative decision. Staff will continue to monitor your case during regularly scheduled program reviews. Transfer is not warranted at this time.

Your appeal is denied.

The Unit team is recommending disapproval for this request based on the nature and severity of his instant offense, and the following information:

Inmate Jayyousi was sentenced to a 152-month term of confinement with 20 years of supervised release to follow for Conspiracy to Murder, and Kidnap and Maim Persons in a Foreign Country. The offense involved inmate Jayyousi participating in a U.S. based support cell that provided money, personal assets, and other services to terrorist groups engaged in murder, kidnaping and maiming overseas. He has a current projected Good Conduct Time Release date of September 15, 2017. Inmate Jayyousi was designated to FCC-Terre Haute, Indiana, arriving on June 18, 2008. He is a Low security inmate with IN custody. Inmate Jayyousi has no prior criminal conviction history. I can't give you anything to add. You and the Warden have to make your recommendation based on institution programing, then we would add comments to go to NCR.

Reviews should be conducted based on the following criteria.

In determining whether continued CMU placement is necessary, the Unit Team will consider whether the original reasons for CMU placement still exist, including whether:

+ The inmate's current offense(s) of conviction, or offense conduct, included association, communication, or involvement, related to international or domestic terrorism;

| The inmate's current offense(s) of conviction, offense conduct, or activity while incarcerated, indicates a propensity to encourage, coordinate, facilitate, or otherwise act in furtherance of, illegal activity through communication with persons in the community;

| The inmate has attempted, or indicates a propensity, to contact victims of the inmate's current offense(s) of conviction;

The inmate committed prohibited activity related to misuse/abuse of approved communication methods while incarcerated; or

| There is any other evidence of a potential threat to the safe, secure, and orderly operation of prison facilities, or protection of the public, as a result of the inmate's unmonitored communication with persons in the community.

Reviews for continuing CMU designation are done in a manner consistent with sound correctional judgement and security threat management practices. Additional information to be considered includes whether the inmate can safely function in a less-restrictive unit without posing a risk to institutional security and good order, posing a risk to the safety and security of staff, inmates, or others, including the inmate himself, and/or posing a risk to public safety. Ultimately, it must be staff's assessment that the inmate does not require the degree of monitoring and controls afforded at a CMU.

Unit Team staff will forward their recommendations to the Warden. With the concurrence of the Warden, recommendations will then be forwarded to the Bureau's Counter Terrorism Unit (CTU) for review of individual inmate cases. The CTU will forward the recommendation to the Regional Director, North Central Region, for further review and consideration. The Assistant Director, Correctional Programs Division, has final authority to approve an inmate's re-designation from a CMU.
