Secretary Brown—Thank you so much for attending the Louisiana Clean Fuels Conference this morning. I also appreciate the time you made available for those members who had individual questions. As I mentioned, I am a governmental relations consultant and I do a great deal of work in the oil and gas industry. Two quick questions for your consideration:

1. I was at the DEQ/Army Corp. hearing on the Bayou Bridge Pipeline and I was sincere when I said this was the best run meeting that has been held anywhere in the country with such diverse attendees and passionate opinions. I expect that those passions may be even greater at our Napoleonville meeting. We are bringing quite a few oil/gas/pipeline supporters to that meeting and would like to know, in advance if possible, what the format will be so we can prepare logistics such as arranging overnight stays, meals, etc. for our supporters. I know you mentioned that this meeting will be hosted by DNR. If you have a contact there, I will be glad to follow-up myself. However, if you find out before then, please let me know so I can make appropriate arrangements.
2. As the Chairman of the Clean Fuels Coalition, I support and promote all alternative fuels. However, my oldest client is the Propane Gas Industry in Louisiana. We are regulated by the LP Gas Commission under Executive Director John Alario (yes, it's the senator's son!). We are very interested in promoting propane autogas and infrastructure improvements with a portion of the Volkswagen settlement money. Please keep the Propane industry in mind when developing these plans. Louisiana is the number 2 producer of Propane in all of North America. It's not just for heating rural homes and weekend crawfish boils. It is the third most prevalent auto
