I. Introduction

1. Pursuant to rule 13(1) of Rules of Procedure and Evidence, and regulation 24(4) of the Regulations of the Court, the Registry hereby transmits as annexes 1 and 2, a "Motion Seeking Remedies for Repeated Administrative Violations," ("Motion").

II. Procedural History

- 2. On Friday 28 January 2022, the Registry received the Motion by way of an email communication from Mr. Nema Milaninia ("the submitter").¹
- 3. On the same date, the Registry confirmed receipt of the email.²
- 4. On 31 January 2022,³ the Registry informed the submitter that the documents attached to the email could not be filed in the record of the Afghanistan Situation citing non-compliance with Pre-Trial Chamber II's "Decision on submissions received and order to the Registry regarding the filing of documents in the proceedings pursuant to articles 18(2) and 68(3) of the Statute."⁴
- 5. On 31 January 2022, the submitter responded to the Registry requesting the onward transmission of their documents to the Presidency.⁵
