Re: Request Under Texas Public Information Act

Dear Madam or Sir,

I am Senior Counsel at LatinoJustice and am writing to make a request of the Brownsville Police Department pursuant to the Texas Public Information Act, Gov't Code § 552.001 (the "Act").

I can accept the requested documents in digital format. They may be emailed to me as an attachment or delivered through an FTP/FTA system at the email address <a href="mailto:acase@latinojustice.org">acase@latinojustice.org</a>.

The time period for this request is from February 1, 2022 through the present.

## **Documents Requested**

- 1) All documents related to the arrest of Rebekah Lynn Hinojosa on or about February 16, 2022. This requests includes, but is not limited to:
  - a. Any arrest warrant, search warrant, bench warrant or other document authorizing the entry into Ms. Hinojosa's residence for the purpose of her arrest,
  - b. Any tactical plan or pre-deployment plan relating to the entry of Ms. Hinojosa's residence and her arrest,
  - c. All roll calls, memo book entries, or other documents relating to the officers who arrested Ms. Hinojosa,
  - d. All paperwork and documentation relating to Ms. Hinojosa's arrest, including any arrest reports, affidavits, or other documentation supporting the arrest.
  - e.All documents relating to the booking and arraignment of Ms. Hinojosa.
- 2) All communications relating to the arrest of Rebeka Lynn Hinojosa on or about February 16, 2022. This request includes but is not limited to:
  - a. Any communications between Brownsville Police Department and Brownsville City Hall regarding the search for, apprehension of, or arrest and prosecution of Ms. Hinojosa.
  - b. Any communication between Brownsville Police Department and the Cameron County District Attorney's Office regarding the search for, apprehension of, or arrest and prosecution of Ms. Hinojosa.
  - c. Any communications between Brownsville Police Department and any media outlet or any reporter regarding the arrest of Ms. Hinojosa.



- d. Any communication between Brownsville Police Department and any private company, including but not limited to SpaceX, regarding the search for, arrest of, or prosecution of Ms. Hinojosa.
- e. Any communication between Brownsville Police Department and any other person or entity regarding the search for, arrest of, or prosecution of Ms. Hinojosa.
- 3) All data kept by the BPD which shows:
  - a. The date of each and any arrest by the BPD solely for one or more Class B misdemeanors between July 1, 2019 August 1, 2022.
  - b. The date of each and any arrest by the BPD for which the sole charge was for criminal mischief since July 1, 2019.
  - c. The final disposition for each criminal case stemming from an arrest on a charge for criminal mischief since July 1, 2019.
