MEMORANDUM FOR Mr. Raymond Northrop, CACI Country Manager, Iraq

SUBJECT: Request for Termination and Pending Security Clearance Revocation for Mr. Dan Johnson Arising from Misconduct at Abu Gharayb Detention Facility.

- 1. CJTF-7 is requesting the immediate termination of Mr. Dan Johnson and intends to process his security clearance for revocation. These actions arise from his being pictured in a possible abusive situation involving an Iraqi security detainee at Abu Gharayb.
- 2. Mr. Johnson was photographed with a security detainee in a dangerous stress position. This photograph shows actions that are not in keeping with established interrogation procedures. Allowing himself to be photographed is also a violation of established interrogation procedures.
- 3. If CACI and/or Mr. Johnson wish to oppose these actions, we are allowing seven (7) days from the delivery of this memorandum to produce documentation in rebuttal and/or mitigation for consideration by either the Contracting Officer or the appropriate security authorities.

Mr. Elefante,

There are no charges being made against Dan Johnson. The photograph in question is attached for your review. Taking photographs of and/or with detainees is prohibited by the Geneva Convention. The detainee also is in what is perceived as a unapproved stress position. Mr. Johnson has been unable to explain the origin of this picture and any reason why the detainee is in his current position. This official notification is to allow him in conjunction with CACI if necessary to provide any reason or evidence as to what is going on in this picture. Without any further explanation, based on the photograph itself, this

command has no other choice but to have Mr. Johnson removed from the current contract and this reported as a derogatory report with the appropriate personnel security offices.

There are also other pictures of Mr. Johnson prior to this picture. These pictures are not with prisoners and are not in question, but because they are taken in the same area over the same span of time makes it hard for one to believe Mr. Johnson's claim that he doesn't remember being photographed.

If I can be of any further assistance please let me know.

Major Daniels, we seek this information as input that will assist us in determining how best to respond to your recommendation. As stated in my email to you dated May 17, 2004, we are prepared to act as directed by the Command. Unfortunately, our understanding of the circumstances at this point is somewhat sketchy despite the faithful efforts of Scott Northrop to relay the substance of his discussions and interactions with you.

We would appreciate any additional data you could provide regarding the proposed recommendation regarding Mr. Johnson. 
