## **RE: Public Records Request**

To Whom It May Concern:

This is a public records request under Minn. Stat. § 13.03 by the Center for Constitutional Rights ("CCR") to the University of Minnesota ("UMN" or "University"). We seek records related to UMN's offer of employment as Associate Professor with tenure and appointment as the Director of the Center for Holocaust and Genocide Studies at the University to Professor Raz Segal, as well as the rescinding of that offer.<sup>1</sup>

### Records Request

We request the following data and records<sup>2</sup>, from December 27, 2023 through the date which this request is processed:<sup>3</sup>

1. All communications<sup>4</sup> sent or received by the following custodians regarding Raz Segal<sup>5</sup>, including any data related to Prof. Segal's application for employment, offer of
